



Motion to add the review of the committee charters to the Policy C3 supplemental calendar in January's proceeding in January 2021, seconded, passed 7-0-0.

Ranked Choice Voting (SI/MD)

Rob gave a brief presentation on ranked choice voting and what the process could look like if used for the 2021 Board election. Board members asked clarifying questions.

Motion to postpone the conversation on adopting ranked choice voting for the 2021 Election until the January 2021 Board meeting, passed 7-0-0.

Patronage Dividend Resolution (MD)

Motion to approve the patronage dividend resolution as written, passed 7-0-0.

Approval of Board Executive Committee Slate (MD)

Alice gave a brief overview of the Executive Committee slate provided. The Executive Committee is recommending a rearrangement of Board officers before filling the fourth committee seat. Votes were cast via SurveyMonkey and tabulated by Chloe.

2018 Board Resolution (SI)

Cheyne gave an overview of the resolution made by the Board in September 2018 which formally directed the GM to cease efforts to open a grocery store in Pullman. Only two currently seated Board members, Cheyne and Laurene, were on the Board when this resolution was passed. The resolution was presented for the benefit of the other Board members to have going into the upcoming Strategic Vision committee meeting with Columinate.
